

Tender may be submitted in sealed envelope, addressed to the Executive Engineer, DWS Division, Kamalpur, Dhalai Tripura, either by registered post with A/D, so as to reach by 3.00 PM on or before **11/01/2022** or dropped in the tender box of the Office of the undersigned /Office of the Executive Engineer, DWS Division, Agartala-I & Rig Division, Agartala on any working day upto **3.00PM on 11/01/2022**.

Earnest money in the form of 'Deposit-at-call' will have to be deposited in any schedule Bank guaranteed by the R.B.I in favour of the undersigned. The deposit at call must be submitted along with the tender. Earnest money in any other form will not be accepted. Tender without earnest money shall be summarily rejected.

1. The intending tenderer shall have to submit separate application for each work along with following attested documents for obtaining tender documents /Forms. These below mentioned (1-A,B,C) attested documents shall also be submitted along with the tender, failing which the submitted tender will be liable for rejection/treated as informal.
 - A) Valid Tax clearance certificate/ GST certificate, & PTC certificate issued by the competent authority in the name of the tenderer (validity should be the last date of tender submission as mentioned in NIT)
 - B) Valid PAN Card of the tenderer
 - C) Valid driving license of driver, valid registration of commercial vehicle, valid route permit and valid fitness certificate of the vehicle from transportation Department, Government of Tripura, shall have to be furnished along with the tender, failing which the tender shall be liable for summary rejection.
